## MEMBER/OUTSIDE PRODUCER BROADCAST AGREEMENT

1. I have read and am familiar with the Policies and Procedures of Lynn Community Television ("LCTV").
2. I agree that I will be responsible for the content of the program materials created by me, and agree that such program materials will not include.
  - a. any obscene or profane material;
  - b. any lottery or lottery information;
  - c. any advertising that falls outside of what a sponsorship would entail. If you are not sure what a sponsorship entails please speak with a staff person and request a copy of the sponsorship policy;
  - d. any direct or indirect solicitation of money;
  - e. any material which constitutes libel, slander, an unreasonable invasion of privacy rights, violation of trademark or copyright, or which would or be reasonably deemed to violate any local, state or federal laws.
3. I acknowledge that I am responsible for obtaining all clearances, licenses, etc. for the use of content in your program materials; including, but not limited to, approvals by broadcast stations, sponsors, music licensing organizations, copyright owners, performers, talent appearing in the program material and/or any other approvals that might be necessary in order to cablecast the program on Lynn Community Television.
4. I shall indemnify and hold LCTV harmless against any claims arising out of any use of the program material that I cablecast or any breach of this Access User Agreement; including, but not limited to, any claims in the nature of libel, slander, invasion of privacy, noncompliance with applicable laws and unauthorized use of copyrighted material.
5. I agree that I shall not represent myself or any associates of mine involved in the production of program content as an employee, representative, or agent of Lynn Community Television, unless specifically authorized by LCTV to do so.
6. I understand that I may be liable for the costs of repair or replacement for any equipment or other materials resulting from: (i) damage beyond reasonable wear and tear through normal use; (ii) misuse; and/or (iii) theft while in my possession or control.
7. I shall indemnify LCTV against any damage or liability that may occur while using the equipment.
8. Before using equipment, I will take a class given by LCTV or an entity or person approved by LCTV to learn how to properly use and safely handle the equipment and other materials. I agree to take a further class(es) as may be required by LCTV going forward based on any need or any change of circumstances as determined by LCTV. I understand that equipment or other materials must be returned on time or used in the allotted time, unless given permission to keep using them for longer by a LCTV staff person.
10. I shall not use Lynn Community Television's channels, equipment, or facilities for any financial gain or or a commercial purposes). I understand that program content produced with LCTV's equipment or facilities shall be for the benefit of the community.
11. I understand that violation of the terms of this statement is grounds for forfeiture of the right to use LCTV equipment, facilities or channel time.
